

Behind the Scenes at The Rivers Casino

Join Kenneth T. McCabe at The Rivers, located on Pittsburgh's North Shore, and earn more about how gambling began, the influence of organized crime in gambling's early days in Las Vegas and how our casinos are run and being protected from syndicates and criminals. You'll hear from a State Trooper about crime inside and outside of the casino, and whether table games will have a negative affect on crime. The night will end with a tour of the back rooms of the casino, from security monitoring to administrative areas.

Ken McCabe is the former SAC of the Pittsburgh office and has been a Commissioner on the PA Gaming Control Board since its inception in 2004. Members who know Ken know this will be a very fascinating session.

The session will be held at The Rivers Casino May 19. The session begins at 7:00 PM.

There will be a \$15.00 per person registration fee, and some sessions may be open to non-Members.

As a member of the FBI Pittsburgh CAAA you are allowed to attend two of the 2010 Citizens' Academy classes. The FBI has opened specific classes for the CAAA. You may choose:

March 31, 2010— Overviews of

Counterintelligence Program, Violent Crimes and Criminal Enterprise Program and Weapons of Mass Destruction (WMD)

April 7, 2010—Overview of:

Use of Force, Polygraph Demonstration and Undercover Operations Program

Classes are held at FBI Division Headquarters. Registration begins at 5:30 PM, dinner is at 6:00 PM and the class begins by 6:30 PM and is completed by 8:00 PM.

There is no charge for attending these classes or for the meal.

Class size is limited to 10 Alumni.

Advance Registration is required.

You must pre-register by calling Mary Jean Lengwin at 412-915-7111 (You may leave a message) at least 1 week prior to the class date. (Ex.: Call by March 17 if you want to attend the March 24 class.) All reservations will be confirmed by e-mail or phone.

No one can be admitted to the FBI later than 6:00 PM. No exceptions.

You must leave all cell phones in your car. Security requirements do not allow any electronic devices in the building.

Last year's range night, with all 25 of our 25 slots being filled, was an extraordinary event. No one minded the cold, shooting in the dark, or the dizziness after climbing out of the Skid Car.

The CAAA Range Night will be held at the updated Monroeville Police Range located in Monroeville, PA.

A buffet dinner will be served at 5:30, followed by Special Agent Ed Daerr's Range Safety Presentation. You must be at the range by 6:00 PM and attend the range safety presentation.

You will be taught by members of the SWAT Team and other volunteer Agents. Three different weapons will be used, based upon the availability of the guns and ammunition. Take your target home at the end of the evening, and if you attended last year's event, see if you've improved with time!

Directions and maps will be given to the registered participants. Plan additional travel time as you will need to fight the rush hour traffic to the range, and allow time just in case you get lost.

This event is limited to 35 CAAA Members.

The cost for the event is \$50.00,

which includes your meal, the range, use of the weapons, ammunition and targets. This is an increase from last year's fee, but still remains a bargain compared to standard range & ammunition fees.

Registration is on a first-come, first-served basis. Please complete the registration form and return it with your \$50.00 payment no later than April 10, 2010. In the event of a cancellation, your fee will be refunded only if you have cancelled prior to April 10, or if we can fill your slot with a wait-listed Member.

A wait-list will be kept in the event of a cancellation.

On Tues. July 20, travel on your own to Stafford, VA. It is an easy 5-hour drive to Stafford where a block of hotel rooms will be on hold for us. When you have checked into the hotel, stop by our Member's Hospitality Area for a cold drink, snacks and conversations with your other Alumni.

On Weds. July 21, the day of the tour of the FBI Academy, we will meet in the lobby after breakfast and travel by motor coach to the Quantico Marine Base, where the FBI Academy is located. The tour begins at 8:30 AM and ends at 4:30 PM.

At the end of the tour we will drive back to our hotel. Dinner will be on your own, or you can join in with your other Alumni at a local restaurant. Details will be available the day of the trip.

On Thurs. July 22 we will leave Stafford by motor coach for the drive to DC. The FBI Headquarters tour is a 1/2 day event, beginning at 8:00 AM and ending at noon.

We listened to our Members, and we will try to meet your request. This year you will have the option of attending one or both tours. The only way that this will work for everyone is that Members who are registering for both Tours will be given immediate confirmation, and Members requesting only one tour will be wait listed.

Your costs will include the \$15.00 per person registration fee, your hotel and meals. We are working with the Holiday Inn Express in Stafford, VA to block a group of rooms at a reasonable price. The information will be finalized in April and will be e-mailed to all Members at that time.

Your \$15.00 registration fee per person will be refunded only if you have cancelled prior to June 19, 2010 or if we can fill your slot with a wait listed Member.

Quantico and FBI HQ limits this tour to 30 Members. You may wait-list a spouse or guest (21+ years of age) if we do not fill all of the spots with Members.
